## School District's Dress Uniform Response

In response to inquiries concerning Clayton County Public Schools relaxing the requirement of uniform dress, please see the following statement on behalf of the School District:

Clayton County Public Schools (CCPS) Superintendent/CEO of Schools, Dr. Morcease J. Beasley, and the Board of Education have not released a formal statement in regards to revising policies/procedures centered around the school district's Uniform Dress Code for elementary and middle students or the Dress and Grooming Code for high school students.

Please be advised that the current J Policy Series, JCDB (Student Dress Code) (Policy), JCDB-R(1) (Student Dress Code) (Regulation) and JCDB-E(1) (Student Dress Code-Contract) (Exhibit) will remain in effect for the 2018-19 school year unless otherwise decided upon and communicated officially by district and school officials.

As leaders, we will continue to engage all stakeholders as they remain instrumental in supporting our culture of high performance and various endeavors relative to achieving our goals. We look forward to further dialogue about the uniform dress matter and appreciate your partnership as vested community stakeholders.
