Clayton County Board of Education to Meet Monday, May 3, 2021

JONESBORO - The Clayton County Board of Education will conduct a **Regular Board Meeting** on Monday, May 3, 2021. The meeting, which will be a combination in-person/virtual session, will be held at the Clayton County Public Schools' (CCPS) Performing Arts Center (PAC), 2530 Mt. Zion Parkway in Jonesboro, and is scheduled to begin at 6:00 p.m. The agenda for this meeting is attached

The board meeting is in-person (face-to-face), but due to social distancing requirements, members of the public are asked to view the livestream. The only exception will be students who will be recognized by the Board and community leaders.

Submissions to the Board must adhere to its **Civility Policy**. Use of abusive language and/or personal attacks in the submitted email will not be permitted and will not be read into the Board meeting record.

All comments/questions must include the name and reply email address of the submitter. Submissions without this information will not be included in those that will be read into the record during the Board meeting.
